RULES FOR MANAGING COMMITTEE-ELECTION

- a) The election to the Managing Committee shall be held in Month of March every year as per instructions received from RBA. The election shall be conducted by poll of the members present at the meeting through single transferable vote. No proxy shall be allowed.
- b) The members of the Managing Committee elected at the Hyderabad Branch SICASA Elections underclause (a) shall assume office after the conduct of the Managing committee meeting in which the Vice Chairman, Secretary and Treasurer will be nominated and shall hold office ordinarily for a period of one year.
 - (i) Every student who is a member of the Students' Association on 1st March 2025 shall be entitled to vote provided he continues to be a member on the date of election.
 - (ii) Every student who fulfils the requirement at (i) above shall be eligible to stand for election to the Managing Committee of the Students' Association to which he belongs provided the un-expired period of training is not less than 12 months as on 1st March of that year.

Any member desirous of standing for election shall submit the nomination form along with the student IDCard (to be down loaded from SSPPortal)and the approval letter from their Principal duly signed to the Chairman of the Students' Association Managing Committee appointed bythe Regional Council concerned in this behalf, duly signed by him and by the proposer and seconder (both of whom shall be person entitled to vote in the election)so as to reach the said SICASA CHARIAMAN Hyderabad @ Hyderabad Branch of SIRC of ICAI, ICAI Bhawan by hand with affixed photograph before the last date of filing nominations; This is apart from filling the Google form which is also part of the requirements.
