It is to inform you that, the Government of Andhra Pradesh has formed A P Maritime Board to look after the operations and development of non-major ports in the state. Further, the Government have formed three SPVs i.e. Ramayapatnam Port Development Corporation Ltd., Machilipatnam Port Development Corporation Ltd., Bhavanapadu Port Development Corporation Ltd., for the development of three Greenfield ports at Ramayapatnam, Machilipatnam, and Mulapeta respectively. Construction of all these three ports and Kakinada Gateway port are taken up with an estimated cost of Rs. 14,446.96 Crores. Further, APMB has also taken up the construction works of 10 Fishing Harbors and 6 Fish Landing Centers in various districts in the State with an estimated cost of Rs.3,666 Crores.

About the Organization:

Andhra Pradesh is endowed with a Coastline of 1053.07 kilometers, the second largest in India, and strategically located on the country's eastern seaboard, Andhra Pradesh understands the importance of developing seaports and is poised to leverage its inherent maritime advantage. Andhra Pradesh was amongst the first maritime states to recognize the imperative need for increased modernized port infrastructure and the role that the private sector would be required to play in developing the same.
