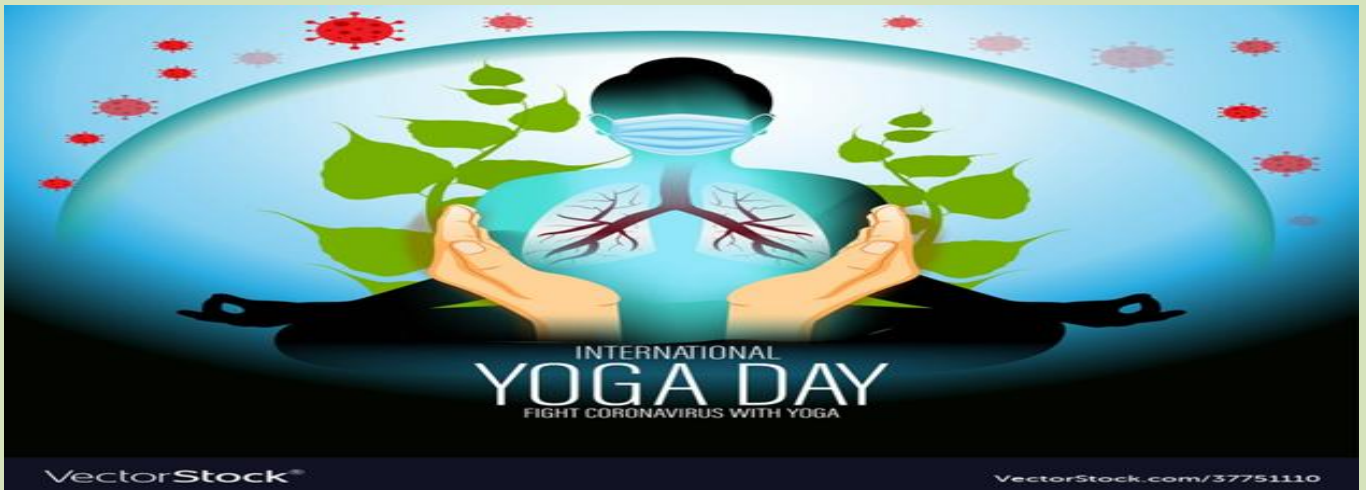

CPE PROGRAMMES:

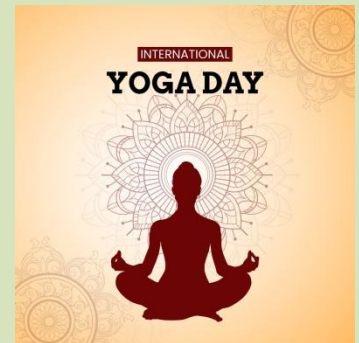

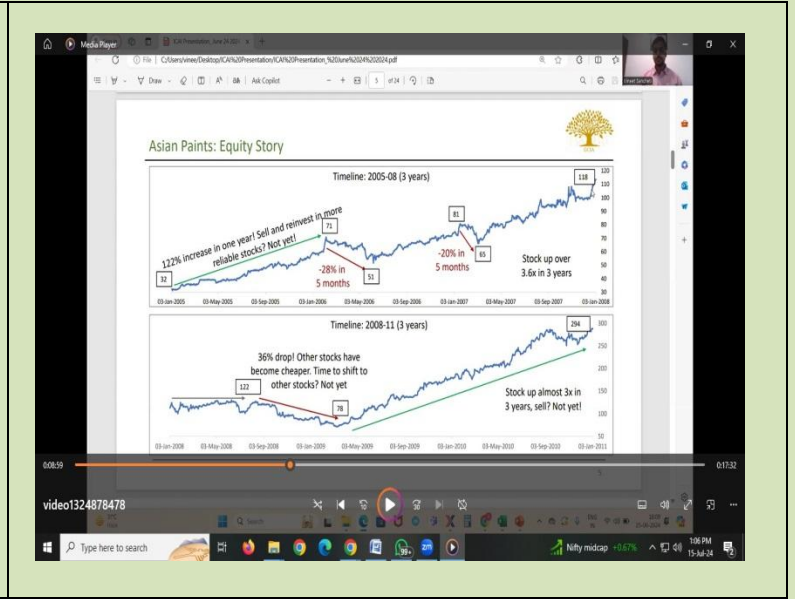
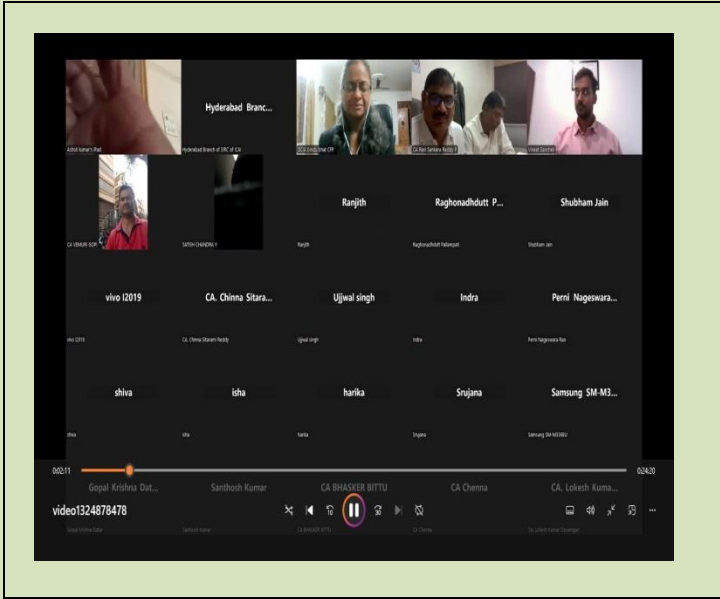
